# 1. APOLOGIES FOR ABSENCE

There were no apologies to receive.

#### 2. DECLARATIONS OF INTEREST

Governors / Members were invited to declare any direct, indirect, pecuniary, personal or prejudicial interest relating to any item on the agenda for the meeting.

There were no declarations made.

# 3. MINUTES OF THE MEETING HELD ON 18<sup>TH</sup> JUNE 2021

# 3.1 Approval of the Minutes

Agreed that: the minutes are signed as a correct record and authorised for publication

## 3.2 Matters Arising

The Head of Governance presented the action progress log and it was noted that all the actions had been completed or included on the agenda for discussion.

In response to a question regarding Governors who had expressed an interest in a future Chair / Committee Chair role, the Head of Governance confirmed that discussions had been held with those members.

# 4. GOVERNANCE SELF ASSESSMENT REPORT (SAR) 2020-21 & ACTION PLAN 2021-22

The Committee considered the revisions that had been made to the SAR at the meeting held on 5th October. It was noted that no further additions or amendments had been suggested by Governors after the meeting.

# **RESOLVED:**

The Committee endorsed the revised SAR and Quality Improvement Plan and agreed that it was submitted for validation at the College SRG meeting.

The Committee expressed its thanks to the Head of Governance for her excellent work and contribution to the production of the SAR.

# 5. BOARD AND COMMITTEE MEMBERSHIP

#### 5.1 Terms of Office

It was noted that the size of the Board had recently been increased for succession planning purposes as some Governors will have served their maximum term of office and could not be re-appointed.

# 5.2 Committee Membership

## Standards & Curriculum

The meeting was informed that there were currently 11 members on the Standards & Curriculum Committee and Governors needed to consider whether this created any issues in relation to giving sufficient time for each member to contribute and challenge/debate, whilst also being able to reach consensus on decisions.

Governors agreed that whilst this was a large Committee, there was a very good mix of skills and experience which enabled appropriate scrutiny and challenge to be provided in all areas of the curriculum. The size of the Committee would reduce as Governor / Co-opted member terms of office came to an end in the next 12 to 18 months.

# **Finance Committee Chair**

The Head of Governance informed members that Jacqui Chatwood would be stepping down as Chair of Finance and from the Board at the end of August 2022.

## 5.3 Committee Structures and membership numbers

Governors reviewed the current Committee structure and size of each Committee and agreed that it was important for each Committee to have at least 5 members to assist with quoracy.

#### **RESOLVED:**

The Committee confirmed that it was content with the current structure but that members were given the option to join an additional Committee should they wish to.

## 6. GOVERNOR TRAINING ARRANGEMENTS

A draft procedure for Governor training was presented to the Committee for consideration.

The Committee agreed that the procedure was documented and suggested including a tour of the College as part of the Governor induction programme.

In response to a question, it was confirmed that Governors had access to the ETF online Governance development programme.

#### **RESOLVED:**

The procedure for Governor induction and training was approved subject to the inclusion of a tour of the College.

#### **ACTION:**

- Head of Governance to amend procedure and re-circulate to Committee members
- Head of Governance to re-circulate links to the ETF Governor training modules

#### Link Governor - Careers

The Committee was informed that a link Governor for Careers would need to be appointed as part of the requirement for meeting the Gatsby benchmarks.

It was suggested that Dominic Martinez was approached for this role as he had the relevant experience to undertake the role.

The Committee reviewed the terms of reference and completed the self-assessment exercise the results of which would be used to assess the Committee's performance and promote continuous improvement.
