All applicants must have 3 A levels equivalent and worked in HR/line management in some capacity OR a degree in any subject and no HR experience.

Learners will also need to become a member of The Chartered Institute of Personnel & Development (CIPD) and will need to pay the annual CIPD membership fee, currently £149 (price correct February 2023). Please note that if you are joining or re-joining CIPD membership there is an administrative charge of £40 in addition to the membership fee.
