Students will gain competencies in drafting financial statements for limited companies, recommending accounting systems strategies and constructing and presenting complex management accounting reports.

Learning Method

Entry Requirements

AAT Level 3 Advanced Diploma in Accounting or a L3 Accounting qualification from another awarding body. You should have GCSE Maths and English at Grade C/4 or an equivalent qualification. Applicants without these qualifications but sufficient life /work

experience will need to complete an AAT skills test to assess their eligibility. The ability to word process under time constraints is also essential.

To be accepted on the course, other factors will also be taken into consideration including:

- commitment to study
- previous skills, experience and success
